Having taken into account the conditions as arising from dry spell, poor crop conditions, ascertained the distress situation that is likely to develop in the area affected by these conditions through crop field verification and on the basis of reports available from the Collector, Deogarh and Nabarangpur, the State Government in continuation of earlier Notification No. 8537/ R & DM (DM) dated the 31<sup>st</sup> October, 2018 and subsequent Corrigendum No. 8716/ R & DM (DM) dated the 6<sup>th</sup> November, 2018 do hereby declare drought of moderate/severe nature in an additional area of 23840.03 hectares in 895 villages under 187 Gram Panchayats of 11 Blocks and 9 wards of 2 ULBs in 2 districts (as per the details given below).
