ORDER

In partial modification of the Government in Revenue & Disaster Management (Disaster Management) Department Order No.2035/R&DM(DM) dated 27.3.2020 read with Order No.2056/R&DM(DM) dated 30.03.2020 relating to complete lockdown in the entire State of Odisha until midnight of 14th April,2020 with a view to ensure strict social distancing and isolation to contain the spread of COVID-19, the State Government do hereby make the following amendments to the said order, namely:-

1. In clause 3 -

- i. in sub-clause (h) of the Exceptions, the words "which include distribution of food items and nutrition support by Anganwadi Workers, once in 15 days, at the door steps of beneficiaries – children, women and lactating mothers" shall be added at the end.
- ii. in sub-clause (k) of the Exceptions, the words "and include direct marketing, facilitated by the State Government, directly from farmers/ group of farmers, FPOs Cooperatives, etc." shall be added at the end.

2. In clause 4, the following paragraph shall be added at the end.

"Hospital and related medical services include AYUSH services i.e. sale and distribution of drugs, hospital dispensaries, individual clinics and telemedicine facilities. Opening of temporary centres for collection of samples, movement of lab technicians and transportation of samples from the collection centres to the laboratories shall be permitted."

3. In clause 5, after sub-clause (a) of the Exceptions, the following Explanation shall be added.

"Explanation- Food and grocery shall mean all items of food and grocery that are usually consumed by people on day to day basis and include, among others, hygiene products such as hand washes, soaps, disinfectants, body wash, shampoos, surface cleaners, detergents, tissue papers, toothpaste, oral care, sanitary pads, diapers, charger and battery cells."

4. In clause 6 -

- i. in sub-clause (a) of the Exceptions, after the word "drugs", the words "including AYUSH drugs" shall be inserted.
- ii. in sub-clause (f) of the Exceptions, after the word "drugs", the words "including AYUSH drugs" shall be inserted.
