**ORDER**

WHEREAS, with a view to ensuring strict social distancing and isolation to contain the spread of COVID-19 pandemic, the Government of Odisha in Revenue & Disaster Management (Disaster Management) Department, vide Order No.2444/R&DM(DM) dated 3rd May, 2020, has extended the lockdown in the entire State of Odisha until midnight of 17th May, 2020 with different stipulations contained therein;

AND WHEREAS, most of the activities having been permitted in Green Zones, it is felt necessary to allow plying of buses to facilitate movement of people to perform such activities;

AND WHEREAS, as per the Ministry of Home Affairs, Government of India Order No.40-3/2020-DM-I(A) dated 1st May, 2020, plying of buses with passengers up to 50% of their seating has been allowed in Green Zones;

NOW, THEREFORE, the State Government, in partial modification of the Order No.2444/R&DM(DM) dated 3<sup>rd</sup> May, 2020, do hereby allow plying of buses on both intra-district and inter district routes in Green Zones subject to following restrictions:

- i. The buses will ply with passengers up to 50% of their seating capacity.
- ii. They will ply exclusively within Green Zones without passing through the territory of any Red Zone or Orange Zone.
- iii. Plying of buses within Green Zones shall be further subject to fulfilling other statutory requirements such as valid route permit, registration certificate, fitness certificate, pollution under control certificate, insurance, etc.






