## **OFFICE MEMORANDUM**

Subject:- Guidelines for Constitution and Administration of National Disaster Response Fund – Reconstitution of the High Level Committee (HLC).

The undersigned is directed to state that the Government of India has issued the Operational Guidelines on Constitution and Administration of National Disaster Response Fund vide its OM No.32-3/2010-NDM-I, dated 28<sup>th</sup> September, 2010. As per the Guidelines, a High Level Committee decides the quantum of assistance from National Disaster Response Fund in case of severe natural disasters.

- 2. It has been decided, with the approval of the competent authority, to reconstitute the said High Level Committee as follows:-
  - (i) Home Minister
  - (ii) Agriculture Minister
  - (iii) Finance Minister
  - (iv) Deputy Chairman, Planning Commission

Special Invitee:-

Vice-Chairman, National Disaster Management Authority.

- 3. The aforesaid Committee will be chaired by the Home Minister.
- 4. The High Level Committee will be serviced by the Disaster Management Division of the Ministry of Home Affairs. The Committee will take into consideration the proposals for Central assistance in the wake of natural disasters based on the Memorandum submitted by the States for Central assistance, and the report of the Inter-Ministerial Central Teams deputed to the affected States for assessment and the recommendation of the Sub-Committee of National Executive Committee thereon and the existing items of expenditure and norms of assistance for such relief.
- 5. The releases to the State Governments from National Disaster Response Fund will be made by the Ministry of Finance as per the decision of the said High Level Committee.
- 6. This supersedes the earlier Office Memorandum No.32-17/2008-NDM-I dated 18<sup>th</sup> August, 2012 issued by the Ministry of Home Affairs.
