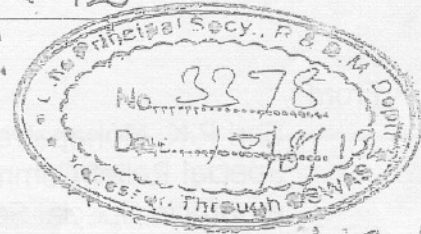



1	Heat Wave	Rs.10,000/- (Rupees Ten thousand)only
2.	Lightning	Rs.1,50,000/- (Rupees one lakh fifty thousand)
3.	Boat Accident (Normal time)	Rs.1,50,000/- (Rupees one lakh fifty thousand)
4.	Tornado & Whirlwind (Normal time)	Rs.1,50,000/- (Rupees one lakh fifty thousand)





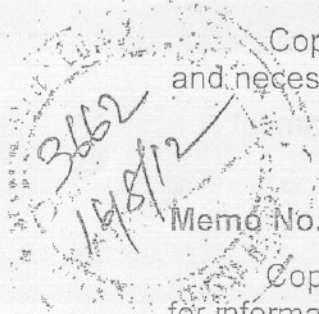

2	Lightning, Boat Accident (Normal time), Tornado & Whirlwind (Normal time)	Rs.1,50,000/- (Rupees one lakh fifty thousand)

Necessary action may, therefore, be taken for sanction of ex-gratia assistance at the revised rates and copy of the sanction order furnished to this office for release of funds.


The revised rates may be circulated among all Sub-Collectors, Tahasildars and other field officers.


