**CORRIGENDUM REQUEST FOR EXPRESSION OF INTEREST NOTICE

**1. Paragraph 4 A is revised as follows.**

**4. Deliverables**

**A. Application**

- i. Software licensing (1 Year Warranty Period) and 2 years of AMC for SEOC and 30 district DEOCs for unlimited users. Various line Departments/ESFs will also need access to the application during response.
- ii. Hosting of the application in Cloud (AWS or MS AZURE or similar) for 3 years.
- iii. Required Training for all the stake holders including 30 districts at a central location in Bhubaneswar.

**2. Paragraph 4 D is revised as follows.**

**D. Support and Maintenance for next 3 years including software licensing period.**

- i. Monitored email & telephone support
- ii. Remote assistance using Remote Desktop and a Virtual Private Network where available
- iii. Bug fixes and software updates
- iv. Data Import as and when necessary
- v. Planned or Emergency Onsite assistance
- vi. Monthly system health check

**3. Paragraph 21 is revised as follows.**

**21. Performance Security**

The successfully bidder who will be selected for awarding the project shall give a performance warranty for a minimum period **3 years**. 10% of the amount of the order (excluding taxes) shall be deposited in shape of Demand Draft or Bank Guarantee duly pledged in favour of Special Relief Commissioner, Odisha, Bhubaneswar and shall be returned after the performance warranty period is over. The said amount may be forfeited partially or fully for failure to fulfill the terms and conditions of agreement. The Bank Guarantee should be enforceable and payable at Bhubaneswar. No interest will be accrued on the Performance security amount.

**16. General Terms and Conditions**

**(xxviii)** Payment of the contract amount for the project will be payable to the Firm/Agency only after submission of the deliverables stated at paragraph 4 and acceptance of the same by the High Level Committee constituted by the State Government for the purpose in phased manner as follows.

- a) The cost of software including license fee will be paid after successful installation at SEOC, all DEOC and other stake holders, commissioning and Hosting of the application in Cloud (AWS or MS AZURE or similar).
- b) Cost of training charges will be paid after successful impartation of required training to all the stake holders.
- c) 50% cost of the AMC charges will be paid in the beginning of the each AMC year.
